

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to texashauntersconvention.com and Texas Hunters Group, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Texas Hunters Group, LLC include texashauntersconvention.com, Texas Hunters Group and Texas Hunters Convention. The Texas Hunters Group website is a online convention sales site. By using the Texas Hunters Group website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Texas Hunters Group may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. Sharing Information with Third Parties

Tracking User Behavior
